A. <u>Student Disciplinary Hearing</u>

- 2. Does not commit any additional acts of gross misconduct for the remainder of the 2011-2012 school year.

If student 2012-01 does not successfully complete the recommended program at Rosecrance and violates any infraction of gross misconduct during the 2011-2012 school year, this expulsion will be reinstated immediately.
