CALL TO ORDER AND ROLL CALL

The Regular Meeting of the Board of Education was called to order at 6:33 p.m. by President Don Ward.

AUDIENCE TO VISITORS

Nancy Schilling, a life-long resident of Poplar Grove schools, spoke about the industrial installation proposed to be installed in the area. She expressed concern that the Board did not hold a debate concerning the wind turbines. She felt this was a money issue rather than a green issue. She stated that the wind turbines would have negative effects on the health and safety of the community, challenged the amount of tax revenue that would be realized by the district and requested that the Board call Byron to find out what happened to them.

Frank Schier, Editor and Publisher of the *Rock River Times*, stated that he was active in several environmental groups and at first blush thought the idea of wind turbines would be a good thing, until he learned more. He explained how wind turbines would be harmful to people, animals and the environment. He stated that the promise of tax revenues is an empty promise, property would be devalued and they would create increased power lines. He warned that everything is not as it appears.

Linda Lammersfeld, suggested ways to give students extra credit. She then asked the Board members to tell her whether they had attended the meeting last month held by the Concerned Citizens of Boone County at the high school and whether they saw the film "Wind Fall." She read aloud some e-mail between herself and Mr. Ward and gave a litany of the perceived harm caused by wind turbines.

Karen Kenney, stated that she had moved to this district because of the excellent special education services North Boone provides but is now considering moving because of the damage, especially to the inner ear, wind turbines can cause children. She read from an article that spoke on the harmful effects wind turbines have on children, and asked that the Board look into the "serious detrimental effects these industrial installations" would have on the students.

Kerry Kenney, commented that because of the eroding economy, property values have decreased and cited information he received from Michael McCann, Director of the Sports Law Institute and Professor of Law at Vermont Law School in which he stated that property values will drop 25% and stay there because of wind turbines. He also has heard families say that no matter how good the school district is, they would never move into this district if the wind turbines move in. He asked the Board to do their homework.

Julie VanLaar, spoke in opposition to the Truancy Ordinance. She felt that rather than a Truancy Ordinance, the district should meet individually with truant students and "not step on that student's rights." She stated that chronic truancy rose in Belvidere after they passed a similar curfew. She asked the Board to follow state law regarding truancy, address the social issues at stake and request Boone County to revoke this ordinance.

Carrie Savino, asked the Board to consider the issues one family has developed who has 10-15 wind turbines on their land. She stated that there are very important perceived negatives related to wind turbines that must be addressed.

SUPERINTENDENT'S REPORT

Dr. Baule reported that the end of year went very smoothly this year. All grades went out with no problem and, effectively, the district is approximately 95% scheduled for high school. The vast majority of the evaluations indicate that the Teacher Institute Day on June 7 went well, with a couple exceptions.

Dr. Baule also reported that summer school was going well so far. Three programs were offered for pre-kindergarten through 12th grade. He expressed his appreciation to Mrs. Torrison and Mrs. Troller for their work in developing these programs.

The first summer library books were checked out last week. Over 50 children took part the first day. Mrs. Lenser was able to obtain grant funds to support this project, which is being held at the Upper Elementary and Poplar Grove Elementary.

Dr. Baule informed the Board that the district's Title I funding has decreased and, at this time, the state owes the district approximately \$770,000, not including the state aide that has been vouchered but not paid. He anticipated that the district will not receive approximately \$180,000 of that money.

Ten architectural firms participated in the district's Request for Proposals (RFP) last week. Mr. Novak provided tours of all our buildings for the architects. The RFPs are due to the district by June 23 and a recommendation will be given to the Board at their next meeting on July 25.

Dr. Baule informed everyone that the Truancy Ordinance was approved by the Boone County Board last week.

Mrs. Balsley reported that the Policy Committee last met on June 6, 2011. The next meeting date is to be determined.

Business Services Committee

Mr. Ward reported that a Facility/Long Range Planning Committee meeting was not held in June. The next meeting date is to be determined.

Mr. Gratz reported that a Curriculum, Instruction and Assessment Committee meeting was not held in June. The next meeting date is to be determined.

Other Committee Reports

Mrs. Zwart reported that the Community Involvement Committee last met on June 2, 2011. The Committee discussed plans for the upcoming golf outing on Friday, June 24. She informed everyone that tickets for dinner that evening at the Bel-Mar Country Club are still available for \$30 each and \$25 for four or more people. The next Community Involvement Committee meeting is scheduled for July 6, 2011 at 5:15 p.m. at the high school.

Mr. Kinser reported that the Technology Subcommittee last met on Thursday, June 16, 2011. The items of interest discussed were: 1) The TechCare Agreement, the district is going into the 2nd year of this agreement, and the Committee reviewed this past year and plans for the coming year; 2) District computers, presented a plan to replace a quarter of the computers every year; 3) SmartBoards, discussed plans to install more SmartBoards in the district. The next meeting date is to be determined.

UNFINISHED BUSINESS

A. Approval of Amended 2010-2011 Budget

Dr. Baule stated that the Amended 2010-2011 Budget includes all revenue received to date. The budget indicates a surplus this year because of the receipt of just under half of the property taxes due in July (next fiscal year). Some of the stimulus money will be used to pay some salaries.

A motion was made by Mrs. Zwart and seconded by Mrs. Morris to approve the Amended 2010-2011 Budget.

The motion was carried by unanimous roll call.

NEW BUSINESS

A. Resolution Supporting Wind Farm Development

Mr. Ward introduced Mr. John Martin who spoke on behalf of U.S. Mainstream Renewal Power, Inc. Mr. Martin stated that he held an open house on Wednesday, June 15, 2011 at the North Boone Fire Station in Poplar Grove to present information on wind turbines and to answer any questions the community might have. He added that this will create a significant increase in the tax base in Boone County and generate permanent jobs in Boone County that cannot be done overseas. He gave an example of a community in Illinois that doubled their tax revenue within one year. The setback for Lee County is 1400 ft. Lee County is holding a zoning hearing on Thursday and indicators are they will proceed with the installation of wind turbines. The purpose of this Resolution is to show support for the increased tax revenue base in the district and for the wind farm. The Board has no jurisdiction on where wind turbines will be located or special regulation and special use permits. Those are all determined by the County Board. Mr. Martin added that he could be reached at john.martin@mainstream.com should anyone have additional questions.

A motion was made by Mrs. Zwart and seconded by Mrs. Balsley to table the Resolution Supporting Wind Farm Development to the next Board meeting on July 25, 2011. The motion was carried by unanimous voice vote.

B. Health/Life/Dental/Vision Insurance Renewal

Dr. Baule stated that the recommendation is to renew the health insurance with a \$500 deductible for all employees. The recommendation is tied to collective bargaining. Last year, the district saved approximately \$40,000 by going to a deductible of \$1,000 from \$250.

A motion was made by Mrs. Balsley and seconded by Mrs. Zwart to approve the Health/Life/Dental/Vision Insurance Renewal.

The motion was carried by unanimous roll call.

C. Purchase of White Bus

Dr. Baule stated that this is one of the buses being sold by Boone County that is wheel chair accessible. This allows the district not to renew the lease of the white activity bus.

A motion was made by Mrs. Balsley and seconded by Mrs. Zwart to approve the purchase of a white bus from Boone County not to exceed \$6500.

The motion was carried by unanimous roll call.

D. June 2011 Bills

Mr. Kinser stated that because of the costs involved he wanted to bring the payment to Chicago Office Technology Group to the attention of the Board. Now that the network infrastructure is working, the principals requested additional SmartBoards, and the funds for these SmartBoards came from five different places. The district received three quotes for the SmartBoards.

A motion was made by Mr. Kinser and seconded by Mrs. Morris to approve the June 2011 Bills.
