The Authorized Agent should be a full-time employee and have the following qualifications:

- 1. A close working knowledge of all personnel employed by the NBCUSE, including new and terminated employees.
- 2. Access to personnel records, payrolls, and other employee compensation records.
- 3. An adequate channel of communications with the Board of Education or Superintendent.
- 4. Sufficient time to perform local administrative IMRF functions.

As Business Manager of North Boone CUSD #200, it is recommended that Rhonda Boeke be appointed the Authorized IMRF Agent.
