PRECISION SPORTS TRAINING

Contract agreement

This contract agreement made on 27 day of October, 2022, by Mark Robinson, ATC, CSCS (owner: first party) and Arron Sullivan, Athletic Director with North Boone High School (second party).

- I. Said party of the first part covenants and agrees that it shall: Provide a single Certified Athletic Trainer, if available, that will provide athletic training responsibilities during contracted games/events. If medical referrals are needed this party will help coordinate this for athletes to determine their ability to practice and compete. It will also keep records of any major injuries. All services provided are deemed within the capacity of the Precision Sports Training, LLC certifications and licensures.

- II. And said party of the second part covenants and agrees that it shall: Provide payment of a flat rate of \$200 for up to 3 hours of coverage. Once 3 hours is reached it shall provide \$50 per hour in addition to the flat rate for all services rendered. For example: 4 hours of coverage equals \$200 plus \$50. Payment of \$250. It will provide medical information (physicals, allergies, medications, etc.) on all athletes upon request and need. This party will also give access to their stock of Athletic Training equipment as needed. Additional coverage requests for practices, camps, summer events, state tournaments, etc. are all optional and available upon Athletic Director approval.

This contract will begin on October 27, 2022 and continue until August 1, 2023. The signatures below represent the understanding and agreement of both parties. Contract may be altered if both parties are in agreement.
