**Terms and Conditions:**

Full Maintenance Lease: American Bus Sales (ABS) full maintenance lease program is set up on a Three (3) year term. The Customer will pay \$13,865.00 a year for use of the vehicle. (The first payment due prior to or upon delivery of the vehicle) Customer may request a third party deliver the vehicle to Customer at Customer's expense. ABS is not responsible for delivery to Lessee. At the end of the lease term the Customer will return said vehicle back to ABS' facility as defined in this quote as: 12802 N. 103<sup>rd</sup> East Avenue, Collinsville, Oklahoma, between the hours 9:30 am to 3:30 pm, Monday - Friday.

**Maintenance/Warranty:**

ABS will cover all maintenance costs not provided for by warranty. The full maintenance lease includes the replacement of wearable items including but not limited to, tires, brakes, fluids, filters (checked and/or changed), etc.

**Annual Inspection:**

ABS will provide an annual inspection/maintenance program per leased unit at the facility in Collinsville, Oklahoma or another approved facility by ABS.

**Customer will be responsible for the following conditions and items:**

- A Purchase Order or deposit is the first step required from Customer in order to prepare vehicle.
- Customer is required to bring any and all vehicle to/from the designated places of warranty, repairs, recalls and/or inspections.
- Fuel cost and driver's fees must be covered by the Customer for transporting vehicle to and from locations of warranty, repairs, recalls and/or inspections. Vehicle must be returned with the same amount of fuel at time of pick up in order to avoid additional costs.
- Driver: Only licensed CDL drivers with passenger endorsement are allowed to drive vehicle. A copy of the CDL license will be required for ABS files. Customer shall be responsible for any act or omission of each of the licensed individuals driving leased vehicle.
- Insurance: **\$1,000,000 per accident.** Customer will be required to maintain full replacement value on vehicle. A Certificate of Insurance naming ABS as an Additional Insured and listing the type of vehicle with VIN# and the obligatory amount of (\$67,900.00) insurance is required prior to taking possession of vehicle.
- Vehicle Damage: Upon the return of vehicle should there be any damage (deemed up and above normal wear and tear), costs shall be the responsibility of Customer. A post Bill of Lading will be required at the time vehicle is returned.
- Customer will enter into ABS' full Lease Agreement prior to taking possession of vehicle.
