

No	Our county is currently at 20%, our staff is currently getting hit on a regular basis for quarantine or isolation. When multiple staff members of a grade level or building are out - we have no plan for coverage. I would feel much better knowing what the actual coverage plan would be - as subs are difficult to find in this district in a non-pandemic situation. When asked about the return to school, the staff who I represent felt that between our incredibly high positivity rate and the lack of substitute plan, they did not support this plan, so I must vote no - for them.	Yes	As these phases are contingent on positivity percent, this plan is easier to support.
No	Many teachers feel this plan is too disruptive to the current remote learning plan that they are using. Most teachers are using that flex time (8:00-9:00) to teach groups of students. All feel that with the positivity rate rising in the county that they do not want ANY students in the building at this time. They feel we need to follow the metrics of the Health Department.
