It is recommended that the Board approve the workers compensation insurance as proposed by the Prairie State Insurance Cooperative and Williams-Manny, Ins.

The cost of coverage would be approximately \$108,499, an increase of 2% over the prior year renewal amount. (Please note that the Treasurer's bond still needs to be underwritten and costs are based upon \$0.75 per \$1,000.)

**RE:** Workers Compensation Renewal

The renewal for the 2012-2013 Workers Compensation Insurance has been received from the Workers' Compensation Self-Insurance Trust (WCSIT) \$121,728 (14.1% increase). This renewal includes Worker's Compensation, Treasurer's Bond, School Board Legal Liability and Student Accident insurance.

All renewals are based upon estimated payroll amounts within job classifications and actual wages paid are reviewed each year for premium adjustments. With the 2009/10 renewal there was a Multi-year Rate option (3 year commitment). The rate option has expired and another one is available within this renewal if desired. Membership has been declining within the WCSIT program and the financial statements seem to include much larger reserves than in the past, along with continued losses and an accumulated deficit in net assets.

A quote was also received from the Prairie State Insurance Cooperative \$110,548 which includes Worker's Compensation, student accident insurance (normally is a part of the property/liability package) and a treasurer's bond to compare the pricing in a comparable manner. Prairie State is the current Property and Liability carrier.

Current Prairie State Cooperative members are required to access both lines of insurance (Property/Liability and Worker's Compensation). North Boone is one of a few districts that currently does not have both lines. There are currently 98 members in the worker's compensation pool and 100 in the property/liability.

A comparison of the two programs follows. However, based upon the products available and the cost comparison, it is recommended that the worker's compensation and the companion products, including a Treasurer's bond in the amount of \$5 mil. (anticipates highest amount on hand at any given time to be \$20 mil) listed be placed with the Prairie State Insurance Cooperative and Williams Manny as the local insurance pool representative. Total estimated cost is \$108,749 (2% increase).
