Suggested motion: Move to renew Prairie State Insurance Cooperative

and Williams-Manny, Inc.

Recommended action: Approve the motion

It is recommended that the Board approve the renewal of workers compensation insurance as proposed by the Prairie State Insurance Cooperative and Williams-Manny, Inc. The cost of coverage would be approximately \$98,498, an increase of 8.5% over the prior year renewal amount of \$90,795.

It is recommended that the Board approve the renewal of property/liability/auto/umbrella insurance as provided by the Prairie State Insurance Cooperative. The renewal of 2013-2014 is \$86,825, which is a 5.30% decrease from the prior year renewal of \$91,682. This renewal also includes the Board legal liability and student accident insurance.

It is recommended that the Board approve building appraisals as per the Prairie State Insurance Cooperative by-laws - all members must have appraisals based on replacement costs and not market costs, and all appraisals must be from within the last seven years. The cost of the appraisals would be approximately \$350 per school and \$250 for the district office/bus garage and the maintenance shed. Total expense would be approximately \$2,600.

(Please note that the Treasurer's bond still needs to be underwritten and costs are based upon \$0.75 per \$1,000.)
