ATTACHMENT X-A:	Approval of Resolution Authorizing Notice of Honorable Dismissal to Bus Drivers
Suggested Motion:	Move to approve the Resolution Authorizing Notice of Honorable Dismissal to Bus Drivers
Recommended Action:	Approve as presented.

Within the scope of the cost considerations presented to the Board at the March meeting, the administrative team is recommending the elimination of four to five bus routes in the fall. This will be done through a combination of consolidating our less populated routes and eliminating transportation for those students who are not eligible for free transportation under the current school code. These reductions should save the district approximately \$75,000 annually in transportation funds.

**RESOLUTION AUTHORIZING NOTICE OF HONORABLE DISMISSAL  
TO BUS DRIVERS**

**WHEREAS**, the Board of Education of North Boone Community Unit School District No. 200, Boone and Winnebago Counties, Illinois, has received reports and recommendations from the administration concerning the number of bus drivers necessary for the 2011-2012 school year; and

**WHEREAS**, The Board of Education has determined that it is in the best interest of the School District to reduce the number of bus drivers;

**NOW THEREFORE, BE IT RESOLVED** by the Board of Education of North Boone Community Unit School District No. 200, Boone and Winnebago Counties, Illinois, as follows:

SECTION 1: That the Board of Education hereby reduces the number of bus drivers as identified in **EXHIBIT 1** effective at the end of the present school term.

SECTION 2: That the Board of Education hereby determines that those Bus Drivers identified on **EXHIBIT 1**, attached hereto and made a part hereof, are hereby dismissed effective at the end of the present school term.

SECTION 3: That the President and Secretary of this Board of Education are hereby authorized and directed to give to the persons identified on **EXHIBIT 1**, by regular mail and by certified mail, return receipt requested, a written notice of this Board's decision to dismiss them at the end of the present school term, which notice shall be substantially in the form of **EXHIBIT 2**, attached hereto and made a part hereof.

SECTION 4: This Resolution shall be in full force and effect from and after its adoption.
