Suggested Motion: Move to approve the ELL Summer School Program

Recommended Action: Approve as presented.

It is recommended that we offer an ELL Summer School Program this summer for students currently enrolled in Kindergarten through Fourth grades. The program will be four days per week for five weeks. There is no cost for this program as it is paid for through Title III Grant funds. The only cost will be for transportation. Additional program information is also attached.

Program Dates: May 30 – June 2, June 5-8, 12-15, 19-22, 26-29

Program Times: 8:30 - 11:30 am

In addition to the academic program, students attending will have the opportunity to attend After Care provided by the YMCA. Families will have to pay for this care according to the YMCA guidelines. Transportation will not be provided from the After Care program and will be the parents' responsibilities.

English Language Learners (ELL) Summer School

- 1. Target Students: Current Kindergarten through fourth grade students receiving services through the District ELL program. All EL Students receiving services will receive an invitation to attend. There will be two classes, one for primary-age students and the other with elementary-age students, each enrolling a maximum of 20 students.
- 2. Staffing: Each class will be staffed by one certified ESL teacher and one bilingual teacher assistant. One teacher will focus on Math instruction and the other on ELA instruction. A building administrator, school nurse, and secretary will be hired for this program as well as the GenEd and ESY Programs taking place concurrently.
- 3. Program Curriculum: Students will be exposed to approximately 80 minutes of ELA and 80 minutes of Math. The math classroom will give students exposure to "Math Talks." They will be given a photograph where they will be verbally expressing and writing about math questions in the photograph. The class will have an emphasis on vocabulary words for solving word problems. In the ELA classroom, students will participate in leveled small group reading and write about what they learn. Word work, or phonics instruction, will focus on English spelling patterns, prefixes and suffixes. Students will also participate in oral language exercises putting their new vocabulary into action.
- 4. Program Structure: The program will be five weeks in length with students attending for three hours per day, four days per week. Teachers will have 30 minutes of planning and preparation each day.
- 5. District costs: The ELL Summer Program is funded entirely through the Title III Grant. See attached budget sheet.
