

MINUTES of a regular public meeting of the Board of Education of Community Unit School District Number 200, Boone and Winnebago Counties, Illinois, held at the District Administrative Offices, 6248 North Boone School Road, Poplar Grove, Illinois, in said School District at 6:30 o'clock P.M., on the 12th day of December, 2017.

The President called the meeting to order and directed the Secretary to call the roll.

Upon the roll being called, Matt Ellingson, the President, and the following Members were physically present at said location: _____

The following Members were absent and did not participate in the meeting in any manner or to any extent whatsoever: _____

The President announced that the next item of business before the Board of Education was the consideration of a resolution abating the tax heretofore levied for the year 2017 to pay debt service on the General Obligation Refunding Bonds (Alternate Revenue Source), Series 2016, of the District.

Whereupon Member _____ presented and the Secretary read by title the following resolution, a copy of which was provided to each member of the Board of Education prior to said meeting and to everyone in attendance at said meeting who requested a copy:

RESOLUTION abating the tax heretofore levied for the year 2017 to pay debt service on General Obligation Refunding Bonds (Alternate Revenue Source), Series 2016, of Community Unit School District Number 200, Boone and Winnebago Counties, Illinois.

WHEREAS, the Board of Education (the “*Board*”) of Community Unit School District Number 200, Boone and Winnebago Counties, Illinois (the “*District*”), by resolution adopted on the 27th day of September, 2016, as supplemented by the Notification of Sale and Direction for Abatement of Taxes, each dated the 28th day of September, 2016 (referred to herein collectively as the “*Resolution*”), did provide for the issue of \$940,000 General Obligation Refunding Bonds (Alternate Revenue Source), Series 2016 (the “*Bonds*”), and the levy of a direct annual tax sufficient to pay the principal of and interest on the Bonds; and

WHEREAS, the Board has determined and does hereby determine that there are Pledged Revenues (as defined in each Resolution) or other funds irrevocably set aside in the Bond Fund (as defined in the Resolution) sufficient to pay debt service due on the Bonds on July 1, 2018, and on January 1, 2019; and

WHEREAS, it is necessary and in the best interests of the District that the tax heretofore levied for the year 2017 to pay the Bonds be abated:

NOW, THEREFORE, Be It and It is Hereby Resolved by the Board of Education of Community Unit School District Number 200, Boone and Winnebago Counties, Illinois, as follows:

Section 1. Abatement of Tax. The tax heretofore levied for the year 2017 in the Resolution is hereby abated in its entirety.

Section 2. Filing of Resolution. Forthwith upon the adoption of this resolution, the Secretary of the Board shall file a certified copy hereof with the County Clerks of Boone and

Winnebago Counties, Illinois, and it shall be the duty of said County Clerks to abate said tax levied for the year 2017 in accordance with the provisions hereof.

Section 3. Effective Date. This resolution shall be in full force and effect forthwith upon its adoption.
