Recommended action:	Approve the motion

It is recommended that the Board of Education approve the 2021-2022 renewal of workers compensation insurance as proposed by the Prairie State Insurance Cooperative, Inc. The cost for 2021-2022 worker's compensation coverage will be \$90,209. This is a flat rate over the prior year's renewal amount of \$90,465.

It is also recommended that the Board of Education approve the 2021-2022 renewal of property / liability / auto / umbrella insurance as provided by the Prairie State Insurance Cooperative. The cost for 2021-2022 coverage would be \$142,704. This is a 22% increase from the 2020-2021 renewal of \$117,039. This renewal also includes the Board legal liability and student accident insurance.

North Boone will be going out to bid for worker's compensation coverage as well as property/liability/auto/umbrella insurance coverage for the 2022-2023 school year.
