### RESOLUTION AUTHORIZING NOTICE OF REDUCTION OF DAYS EMPLOYED TO EDUCATIONAL SUPPORT PERSONNEL

SECTION 3: That the President and Secretary of this Board of Education are hereby authorized and directed to give to the person identified on **EXHIBIT 1**, by regular mail and by certified mail, return receipt requested, a written notice of this Board's decision to reduce the number of days worked for that employee at the end of the present school term, which notice shall be substantially in the form of **EXHIBIT 2**, attached hereto and made a part hereof.

SECTION 4: The Superintendent or designee shall also personally deliver a copy of said Notice to said employee with a signature receipt. A specimen copy of said receipt is attached in **EXHIBIT 2** and incorporated by reference.

SECTION 5: This Resolution shall be in full force and effect from and after its adoption.
