WHEREAS, the Board of Education (the "Board") of Community Unit School District Number 200, Boone and Winnebago Counties, Illinois (the "District"), by resolution adopted on the 19th day of December, 2006 (the "Resolution"), did provide for the issue of \$5,171,661.35 General Obligation Capital Appreciation School Building Bonds, Series 2006, and the levy of a direct annual tax sufficient to pay the debt service thereon; and

WHEREAS, on the 27th day of December, 2006, a duly certified copy of the Resolution was filed in the offices of the County Clerks of Boone and Winnebago Counties, Illinois (collectively, the "County Clerks"); and

WHEREAS, the District has surplus funds in the "School Bond and Interest Fund of 2006" (the "Bond Fund") established pursuant to Section 8 of the Resolution for the purpose of paying the debt service on the Bonds; and

WHEREAS, it is necessary and in the best interests of the District that a part of the tax heretofore levied for the year 2014 to pay the debt service on the Bonds be abated:

Now, Therefore, Be It and It is Hereby Resolved by the Board of Education of Community Unit School District Number 200, Boone and Winnebago Counties, as follows:

Section 1. Incorporation of Preambles. The Board hereby finds that all of the recitals contained in the preambles to this Resolution are full, true and correct and does incorporate them into this Resolution by this reference.

Section 2. Abatement of Tax. A portion of the tax heretofore levied for the year 2014 in the Resolution shall be abated by that amount representing surplus funds in the Bond Fund, and the amount of the tax levied in Section 8 of the Resolution for the year 2014 to pay debt service on the Bonds, the amount of the tax to be abated for said year, and the remainder of the tax levied which is to be extended for said year to pay debt service on the Bonds are as follows:
