ATTACHMENT NO. XI-D: Resolution Abating Tax on Alternate Revenue Source

Suggested Motion: Move to approve the Resolution Abating the Tax heretofore Levied for the Year 2015 to Pay Debt Service on General Obligation Bonds (Alternate Revenue Source), Series 2008A, of Community Unit School District Number 200, Boone and Winnebago Counties

Recommended Action: Approve as presented.

The Alternate Revenue Bonds were sold to fund the construction of the District Office Building. At that time, the Board desired to abate the taxes necessary each year for the bond payment and fund such revenue needed to make the annual payment with the Sales Tax Revenue received per board vote at October 27, 2014 Board Meeting.

The President announced that the next item of business before the Board of Education was the consideration of a resolution abating the tax heretofore levied for the year 2015 to pay debt service on the General Obligation Bonds (Alternate Revenue Source), Series 2008A, of the District.

Whereupon Member \_\_\_\_\_ presented and the Secretary read by title the following resolution, a copy of which was provided to each member of the Board of

Education prior to said meeting and to everyone in attendance at said meeting who requested a copy:

RESOLUTION abating the tax heretofore levied for the year 2015 to pay debt service on General Obligation Bonds (Alternate Revenue Source), Series 2008A, of Community Unit School District Number 200, Boone and Winnebago Counties, Illinois.

WHEREAS, the Board of Education (the “*Board*”) of Community Unit School District Number 200, Boone and Winnebago Counties, Illinois (the “*District*”), by resolution adopted on the 21st day of April, 2008, as supplemented by the Notification of Sale and Direction for Abatement of Taxes, each dated the 10th day of September, 2008 (referred to herein collectively as the “*Resolution*”), did provide for the issue of \$1,190,000 General Obligation Bonds (Alternate Revenue Source), Series 2008A (the “*Bonds*”), and the levy of a direct annual tax sufficient to pay the principal of and interest on the Bonds; and

WHEREAS, the Bonds were issued by the District pursuant to the terms of the Resolution; and

WHEREAS, the Board has determined and does hereby determine that there are Pledged Revenues (as defined in the Resolution) or other funds irrevocably set aside in the Bond Fund (as defined in the Resolution) sufficient to pay debt service due on the Bonds on July 1, 2016, and on January 1, 2017; and

WHEREAS, it is necessary and in the best interests of the District that the tax heretofore levied for the year 2015 to pay the Bonds be abated:

NOW, THEREFORE, Be It and It is Hereby Resolved by the Board of Education of Community Unit School District Number 200, Boone and Winnebago Counties, Illinois, as follows:

*Section 1. Abatement of Tax.* The tax heretofore levied for the year 2015 in the Resolution is hereby abated in its entirety.

*Section 2. Filing of Resolution.* Forthwith upon the adoption of this resolution, the Secretary of the Board shall file a certified copy hereof with the County Clerks of Boone and Winnebago Counties, Illinois, and it shall be the duty of said County Clerks to abate said tax levied for the year 2015 in accordance with the provisions hereof.

*Section 3. Effective Date.* This resolution shall be in full force and effect forthwith upon its adoption.
