

**RESOLUTION AUTHORIZING NOTICE OF HONORABLE DISMISSAL
OF EDUCATIONAL SUPPORT PERSONNEL**

WHEREAS, the Board of Education of North Boone Community Unit School District No. 200, Boone and Winnebago Counties, Illinois, has received reports and recommendations from the administration concerning the number of educational support personnel necessary for the 2012-2013 school year; and

WHEREAS, The Board of Education has determined that it is in the best interest of the School District to reduce the number of educational support personnel;

NOW THEREFORE, BE IT RESOLVED by the Board of Education of North Boone Community Unit School District No. 200, Boone and Winnebago Counties, Illinois, as follows:

SECTION 1: That the Board of Education hereby reduces the number of educational support personnel in the categories as identified in **EXHIBIT 1** effective at the end of the present school term.

SECTION 2: That the Board of Education hereby determines that those Educational Support Personnel identified on **EXHIBIT 1**, attached hereto and made a part hereof, are hereby dismissed effective at the end of the present school term.

SECTION 3: That the President and Secretary of this Board of Education are hereby authorized and directed to give to the persons identified on **EXHIBIT 1**, by regular mail and by certified mail, return receipt requested, a written notice of this Board's decision to dismiss them at the end of the present school term, which notice shall be substantially in the form of **EXHIBIT 2**, attached hereto and made a part hereof.

SECTION 4: This Resolution shall be in full force and effect from and after its adoption.
