

ATTACHMENT NO. XI-F: Contract Renewal with DRIVE-RIGHT School of Driving, Inc. for 2012-2013 and 2013-2014 School Years

Potential motion: Move to approve the two-year contract renewal with DRIVE-RIGHT School of Driving

Recommended action: Approve the motion.

The Waiver of ISBE Rules for driver education contracting to allow the District to contract for the driver education course from a commercial driver training school for a period of five years was approved on July 1, 2010.

DRIVE-RIGHT School of Driving, Inc. is approved by the Illinois Secretary of State as meeting all the requirements of Chapter 6, Article IV of the Illinois Vehicle Code, their instructors have the appropriate endorsement for driver education issued by the Illinois State Board of Education and their instructors meet the requirements of 23 Ill. Adm. Code 252.40(a)(3).

DRIVE-RIGHT has worked with several school districts for over 20 years, including our district for the last three years. DRIVE-RIGHT has also been exceptional in their assistance in producing vast amounts of paperwork and documentation in reply to FOIAs.

Although DRIVE-RIGHT has not increased their contract rate for the last three years, this year their rate did increase \$15 from \$275/student to \$290/student.

Based upon the above, it is recommended that the district accept DRIVE-RIGHT School of Driving, Inc. for behind the wheel driver's education.

**2 YEAR CONTRACT FOR DRIVER EDUCATION INSTRUCTION
2012-2013 and 2013-2014 SCHOOL YEARS**

In exchange for the fees outlined below, DRIVE-RIGHT School of Driving, Inc. agrees to instruct students of North Boone High School in a driver education course. This course will consist of 6 hours of behind the wheel and 6 hours of observation.

COST OF COURSE PER STUDENT:

\$290 for behind-the-wheel to be paid by the student/parent.

BEHIND THE WHEEL:

The account must be paid in full before the student can start the driving lessons in the car. Payment arrangement may also be made until the account is paid in full. Once the classroom portion starts, and the students get their permit, we will be in contact with the students to arrange driving times. Driving times are during the school day, after school, and on weekends, and will begin and end at North Boone High School.

DRIVER EDUCATION:

Drive-Right agrees to offer and provide driver's education classes to North Boone students on North Boone's campus. Drive-Right shall be solely responsible for planning and presenting the driver's education requirements imposed by the State of Illinois. Drive-Right shall provide all necessary teachers and substitutes. All driver's education teachers or substitutes shall be considered employees of Drive-Right and not employees of North Boone.

TERMINATION:

This agreement may be terminated by either party, without cause, upon one semester's advance written notice, which must be given prior to the beginning of the semester to be effective at the beginning of the following semester.

TIMES AND LOCATION:

Times and locations will be mutually agreed upon between both the school district principal and DRIVE-RIGHT School of Driving, Inc.
