The Lighting Replacement Bids were opened on April 18, 2012 at 2:00 p.m. Fifteen (15) electrical contractors were contacted and seven (7) of these contractors requested bid documents, and seven (7) bids were received.

The lowest bid was submitted by Associated Electric of Woodstock, IL. The Base Bid proposals ranged from \$59,900 (Associated Electric) to \$136,777. The attached Bid Tabulation itemizes the base bid proposals for each bidder.

Cashman Stahler Architects contacted Associated Electric to review their bid and has confirmed the bid appears to be complete and responsive. It is the architect's recommendation that the District accept the Associated Electric bid in the amount of \$59,900. The Base Bid includes a Contingency Allowance of \$4,000.

The scope of lighting replacement includes the replacement of the lighting in the gymnasiums at Manchester, Poplar Grove, Capron, North Boone Middle School, North Boone Upper Elementary and the North Boone High School. In addition to the gymnasium lighting replacement, the scope of work includes the replacement of the lighting in the high school commons area and addressing existing electrical violations or issues associated with the gymnasium lighting at Manchester, Poplar Grove and the middle school. The cost of the lighting replacement work to the District will be offset (approximately one third of the project cost) by reimbursement from a DECA grant.

The original budget estimate prepared by the architect and the electrical engineer for the gymnasium lighting replacement was \$57,500.
