

MINUTES of a regular public meeting of the Board of Education of Community Unit School District Number 200, Boone and Winnebago Counties, Illinois, held at the District Administrative Offices, 6248 North Boone School Road, Poplar Grove, Illinois, in said School District at 6:30 o'clock P.M., on the 17th day of December, 2019.

The meeting was called to order by the President, and upon the roll being called, Joe Haverly, the President, and the following members of the Board of Education were physically present at said location: _____

The following members were allowed by a majority of the members of the Board of Education in accordance with and to the extent allowed by rules adopted by the Board of Education to attend the meeting by video or audio conference: _____

No member was not permitted to attend the meeting by video or audio conference.

The following members were absent and did not participate in the meeting in any manner or to any extent whatsoever: _____

The President announced that the next item of business before the Board of Education was the consideration of a resolution abating a portion of the tax heretofore levied for the year 2019 to pay the debt service on the District's outstanding Capital Appreciation School Bonds, Series 2003.

Whereupon Member _____ presented and the Secretary read by title the following resolution, a copy of which was provided to each member of the Board of Education prior to said meeting and to everyone in attendance at said meeting who requested a copy:

RESOLUTION abating a portion of the tax heretofore levied for the year 2019 to pay debt service on \$9,292,272.20 Capital Appreciation School Bonds, Series 2003, of Community Unit School District Number 200, Boone and Winnebago Counties, Illinois.

WHEREAS, the Board of Education (the “*Board*”) of Community Unit School District Number 200, Boone and Winnebago Counties, Illinois (the “*District*”), by resolution adopted on the 17th day of December, 2002 (the “*Resolution*”), did provide for the issue of \$9,292,272.20 Capital Appreciation School Bonds, Series 2003 (the “*Bonds*”), and the levy of a direct annual tax sufficient to pay the debt service thereon; and

WHEREAS, on the 30th day of December, 2002, and on the 27th day of December, 2002, a duly certified copy of the Resolution was filed in the offices of the County Clerks of Boone and Winnebago Counties, Illinois (collectively, the “*County Clerks*”); and

WHEREAS, the District has available funds in the “School Bond and Interest Fund of 2003” (the “*Bond Fund*”) established pursuant to Section 8 of the Resolution for the purpose of paying the debt service on the Bonds; and

WHEREAS, it is necessary and in the best interests of the District that a portion of the tax heretofore levied for the year 2019 to pay the debt service on the Bonds be abated:

NOW, THEREFORE, Be It and It is Hereby Resolved by the Board of Education of Community Unit School District Number 200, Boone and Winnebago Counties, as follows:

Section 1. Incorporation of Preambles. The Board hereby finds that all of the recitals contained in the preambles to this Resolution are full, true and correct and does incorporate them into this Resolution by this reference.

Section 2. Abatement of Tax. A portion of the tax heretofore levied for the year 2019 in the Resolution shall be abated by that amount representing the available funds in the Bond

Fund. The amount of the tax levied in Section 7 of the Resolution for the year 2019 to pay debt service on the Bonds, the amount of the tax to be abated for said year, and the remainder of the tax levied which is to be extended for said year to pay debt service on the Bonds are as follows:

Section 3. Filing of Resolution. Forthwith upon the adoption of this Resolution, the Secretary of the Board shall file a certified copy hereof with the County Clerks, and it shall be the duty of the County Clerks to abate said tax levied for the year 2019 in accordance with the provisions hereof and as shown hereinabove in Section 2 hereof.

Section 4. Effective Date. This Resolution shall be in full force and effect forthwith upon its adoption.
