2020-2021 School Opening Options

Re-Entry Planning Options

- 1. Regular Opening School begins normally with no limitations.
- 2. Modified Opening School opens with social distancing and safety guidelines that must be followed.
- 3. E-Learning Opening Instruction will be done through distance learning.
- 4. Adjusted Calendar The school calendar may be adjusted to accommodate learning and safety guidelines.

**The district may need to move between options and adjust calendars throughout the year as needed for safety.

***All plans will work off of guidelines and recommendations from the ISBE, IDPH, and the BCHD.

Important Dates

- June 22-26 ISBE will be issuing Re-Entry Guidelines.
- June 26 Meeting with the Boone County Health Department to prepare planning options and county specific guidelines.
- June 30 Meeting with NBEA and NBESS to state and health department guidelines with impact on job responsibilities.
- July 1 Administration will create district and building specific detailed plans that match school and safety guidelines.
- July 21 Board approval Re-Entry Plan(s). The Board will be kept informed of the details as they emerge before the meeting. Different scenarios may still need to be considered as well.

<u>E-Learning/Remote Learning Open:</u> This would be a full implementation of the E-Learning plan. Students would continue to learn remotely. Staff will implement the approved E-Learning plan.

 - K-4 Google Classroom
 - 5-8 Schoology
 - o 9-12 Google Classroom
- Students may need additional social emotional support.
- Platform training for students
- Screening and safety management for each building and grade level
- PPE equipment needs

Staff Considerations:

- New hires will need additional mentoring support.
- Hold a virtual session twice a week with your class (Time considerations Grades K-1: no more than 10-15 minutes for one session; Grades 2-4: no more than 20 minutes for one session; Grades 5-12: no more than 30 minutes for one session).
- If possible, allow teachers in the building at least 1 day a week so they could do their virtual lesson from their classroom.
- TA's would attend sessions to support the flow of discussion.
- Creation of an E-Learning Committee

<u>Modified Open:</u> This would be a modified open to the school year. Social distancing considerations would be taken into account.

Student Considerations:

- Attendance:
 - Students would attend every other day (A day / B day) Monday through Thursday.
 - E-Learning every Monday or Friday for all students. Could follow a flipped-classroom model.

- E-Learning on non-attendance days (A day / B day). Students may be doing lessons with students in class at school.
- Kinder Could we do an AM and PM session so that students come in every day, but only for a half day? Feasibility of sanitization would need to be considered.
- If possible, bring back our youngest students (ideally K-4 and 5-6). Focus on getting them in person instruction as soon as possible.
- Students may need additional social emotional support.
- Additional student trainings
- PE not dressing
- Screening and safety management for each building and grade level
- PPE equipment needs

Staff Considerations:

- New hires will need additional mentoring support.
- Lessons for A/B day structure
 - Teachers would teach the same lesson two days in a row during in-person attendance days. OR
 - Teachers would teach a different lesson each day and the students at home would access through Google Meet or broadcast. (grades 5-12)
 - Teachers would provide E-Learning work for Fridays or Mondays.
- Staff in the building on Friday to prepare for the next week.
- Shared Staff
- Custodial staff and bus staff will need a sanitation schedule
- Staff teaching through remote learning could be needed.

Curricular Considerations:

- Pacing will need to be adjusted to reflect where students are currently at.
- Skills that are typically covered in prior years may have only been introduced to students or not introduced at all.
 - Teachers completed curriculum coverage forms and had vertical articulation meetings in May.
- When planning additional review, assess and instructional time will be needed, especially at the beginning of the year.
- Erin's Law presentations early in the school year.
- Skill-building after school sessions for students.
