Rationale: It is recommended that the Board approve the final contract sum with the change orders and deductions for the Capron parking Lot in the amount of \$1,448,929.00. The final sum is \$43,411.95 over the original bid. The main reasons for the increase were because of 2 areas of unsuitable soil that needed to be removed, removal of an old septic tank, and extra tillage to dry and recompact the soil in several areas.
