

Resolution Accepting Donation

WHEREAS, the Board of Education (the “Board”) of North Boone Community Unit School District 200 (the “School District”) has been notified of the desire of Richard A. Britton Estate (hereafter referred to as the “Donor”) to make a donation to the School District in the form of a cash payment of \$11,500.00 with the stipulation that the FFA/Ag Department at North Boone High School use the intended lease land for hands on educational training and learning (hereafter referred to as the “Donation”); and

WHEREAS, Section 16-1 of the *Illinois School Code*, 105 ILCS 5/16-1, authorizes the Board to accept any grant, gift, donation, or legacy of real or personal property (collectively referred to as “Gifts”); and

WHEREAS, Board Policy 8:80 further authorizes the Board to accept Gifts on all of the following conditions:

1. The Gift be given without a stated purpose or with a stated purpose compatible with the Board’s educational objectives and policies;
2. The Gift is consistent with the Board’s mandate to provide equal educational and extracurricular opportunities to all students, and in compliance with state and federal laws to provide equal treatment for members of both sexes to education programming, extracurricular activities, and athletics, including the distribution of athletic benefits and opportunities;
3. The Gift permits the School District to maintain resource equity among its learning centers;
4. The Gift is viewpoint neutral; and
5. The Gift complies with all laws applicable to the School District, including, without limitation the Americans with Disabilities Act, the Prevailing Wage Act, the Health/Life Safety Code for Public Schools, and all applicable procurement and bidding requirements;

and

WHEREAS, upon acceptance, the Gift will become the property of the School District;
and

WHEREAS, the acceptance of the Gift by the Board shall not be deemed an endorsement by the Board, School District, or any of its schools of any product, service, activity, or program;
and

WHEREAS, the Board finds and determines that the Donation meets the criteria required by Board Policy 8:80 for the acceptance of Gifts.

NOW THEREFORE, BE IT RESOLVED by the Board of Education of North Boone Community Unit School District 200, Boone County, Illinois, as follows:

1. The Board hereby finds the recitals contained in the Preamble of this Resolution to be full, true, and correct and does hereby incorporate them into this Resolution by this reference.
2. The Board hereby accepts the Donation in accordance with the authority granted by 105 ILCS 5/16-1.
3. The Board authorizes the Board President to provide a copy of this Resolution to the Donor along with an acknowledgement of acceptance and gratitude for the Donation.
4. In the event the Donation is in the form of cash, the Superintendent or designee, is authorized to deposit the Donation into the accounts of the School District in the fund determined to be most appropriate by the Superintendent.
5. The Superintendent shall report to the Board the fund into which the Donation was deposited, and shall report the expenditure or use of such donation when made.
6. This Resolution shall be in full force and effect immediately upon its adoption.
