

Issue

Microsoft has announced that it will officially end support for Windows 10 on October 14, 2025. After this date, the operating system will no longer receive security updates, bug fixes, or technical support.

In response, we must begin transitioning district devices to Windows 11 to maintain security, compliance, and compatibility with future applications. This upgrade requires replacing any devices that do not meet Windows 11's hardware requirements, such as TPM 2.0 and compatible processors.

To support this transition, we are recommending the purchase of updated Windows laptops, desktops, and Chrome boxes, which will enable us to replace all Windows 10 devices across our computing environment and ensure a smooth continuation of instruction and operations this coming school year.
