ATTACHMENT NO. XI. E (2): Approval of 6-8 Math Curriculum Adoption

Suggested motion: Move to Approve

Recommended action: Approve as presented.

It is recommended that the Board approve the purchase of *Reveal Math* by McGraw Hill for 6th-8th grade mathematics. This purchase is for six years of consumable and online resources with a total cost of \$52,211.90.

This purchase will come from local district funds.

Recommendation for Adoption 6th-8th Grade Math Curriculum Resources

Rationale:

Our current 6th-8th grade resource is no longer being supported by the vendor, so the teachers have selected a new resource for a core math resource.

Recommendation:

The *Reveal* curriculum resource published by McGraw Hill is recommended for adoption as our 6th-8th grade math resource. The following features stand out as key reasons for our recommendation.

- Uses evidence-based instructional practices for mathematics.
- Directly aligns to the Common Core State Standards (CCSS) for mathematics.
- Includes differentiated resources as well as resources to support interventions at Tier 2.
- Includes customizable assessments with differentiated test questions.
- Includes video tutorials to support students.
- Includes teacher supports, such as: premade presentations, online filters to find resources easily, gradebook synchronization, and reports aligned to standards.
- Aligns to IXL, which is a current online supplemental resource.

Process:

In order to arrive at this recommendation, the 6th-8th grade math teachers engaged in the following process.

- November 2023 January 2024
 - Met to discuss an adoption since current resource no longer supported
 - o Decided on an accelerated timeline to select a new resource
 - o Gathered and reviewed samples from vendors
 - o Selected Reveal Math to pilot
 - o Reveal Math pilot training for teachers
- February 2024 April 2024
 - Piloted Reveal Math unit components with one class or small group at each grade level
